2 Circumstances of Breach

Relevant Principle/Protocol and Practice

Protocol 2, Practice 4 – issue statistical releases at the standard time of 9.30am on a weekday to maintain consistency and to permit time for users to understand and respond to the information during normal working hours

Date of occurrence

5 October 2011

Nature of breach (including links with previous breaches, if any)

Monthly Statistics of Building Materials and Components is published on the BIS statistics website, and also made available through the UKSA Publication Hub. The

release entitled September 2011 was due to be published at 9.30am on 5 October 2011. Although the link from the Hub went live at 9.30am, it went to an error message - the release itself was not published on the BIS statistics website until just after 11am.

Reasons for breach

While the release page is set up in advance of publication, it is not currently possible for it to be published at 9.30am automatically. This must be done manually by a member of the web publication team. A calendar reminder is set to ensure that this is done on time, but the reminder failed on this occasion, and the prepared pages were not released.

3 Reactions and Impact

The breach was noticed by a member of the production team carrying out a routine check on the publication. We are not aware of any user reaction or impact.

4 Corrective Actions Taken (include short-term actions, and long-term changes made to procedures)

The production team immediately contacted the web publication team on discovery of the problem, and the release was published just after 11am.

BIS statistics are currently published on a separate specialist website http://stats.bis.gov.uk. We are in the process of developing a statistics section on the main BIS website http://www.bis.gov.uk and this will start hosting publications later this month. As part of this development, it will be possible to set up releases in advance for automatic publication at 9.30am.

An additional publication date and time publishing diary has been put in place.
