Update on the extent of Pre-release Access to official statistics 2011 to 2012

1. This paper presents an analysis of the extent of Pre-Release Access (PRA) to official statistics across government.

Key findings

- 2. The key findings are as follows.
 - i. The available data indicate that in 2012, PRA was granted to 1,218 sets of statistics, or 71 per cent of all official statistics (Table 1).
 - ii. Looking at statistics for which we have data for 2011 and 2012, it appears that the number of releases to which PRA is granted has increased by 3 per cent (Table 2).
 - iii. The total number of individual instances of PRA (i.e. one person granted access to one release) also appears to have increased by 3 per cent (Table 3) since 2011.
 - iv. The average length of PRA lists in 2012 (i.e. the mean number of PRA recipients for statistics with at least one PRA recipient) was 18.2 people, an increase of 0.4 people since 2011 (Table 4).

Background notes

- 3. During 2011, the National Statistician's Office (NSO) collated information on the extent of PRA across government. This was achieved by a manual check of the websites of official statistics producers for their published lists of people granted PRA. During this exercise, the NSO encountered problems with missing information. For 633 sets of statistics, no information was found about the extent of PRA.
- 4. In 2012 the NSO collected information about PRA by asking departmental statistics Heads of Profession (HoPs) to provide data about PRA directly to the NSO. HoPs were asked to provide details of the number of persons granted PRA for all official and National Statistics published in 2012 by their department and its arm's length bodies. During this exercise, some inconsistencies in the 2011 data were checked and corrected, but the data for 2011 remain incomplete.
- 5. The Scottish PRA Order does not require lists of PRA recipients to be published, and so the 2011 data set did not contain any information about the Scottish Government. However, for the 2012 exercise, the Scottish Government agreed to provide information on the number of PRA recipients, in order that the Authority could monitor changes in future years.
- 6. As the records for 2011 are less complete than those for 2012, it has not been possible to make direct comparisons between the two years of data. To provide an indication of change over time, cases with missing data for 2011 were excluded from the analysis in Tables 2 to 4. These tables are based only on statistics where data exist for both years (matched cases = 1,024), and do not include some departments where no data were available for 2011 (i.e. the Scottish Government, National Records Scotland, ISD Scotland and Ofsted).
- 7. For consistency, the comparative analysis does not include any new sets of statistics (e.g. the Census). The NSO's new method for collecting PRA information should allow for more reliable analysis over time.

Number of releases to which PRA is granted

 The data set compiled by the NSO contains records for 1,713 sets of statistics. Of these, 943 are National Statistics. Table 1 shows that PRA was granted to 71 per cent of all sets of statistics.

9. Looking at the 1,024 sets of statistics for which data exist for both 2011 and 2012, Table 2 shows that the number of releases to which PRA is granted has increased by 3 per cent (not including any new sets of statistics such as the Census).

Number of individual instances of PRA

10. Any one set of statistics can have multiple PRA recipients. Some individuals will have access to many sets of statistics (e.g. Ministers will often have access to many departmental statistics). Table 3 shows that the cumulative total of the number of instances of PRA (i.e. one person granted access to one release) has increased by 3 per cent.
