2. Circumstances of breach

Relevant Principle/Protocol and Practice

Protocol 2: Release practices, Practice 4 - Issue statistical releases at the standard time of 9:30am on a weekday, to maintain consistency and to permit time for users to understand and respond to the information during normal working hours.

Date of occurrence

29/09/2017

Nature of breach (including links with previous breaches, if any)

All components of the release were affected and publication was delayed by 4 minutes.

Reasons for breach

The breach was as a result of human error.

To add time series to the release in readiness for publication at 09.30, it is taken out of the publishing queue and the time-series file (which has run over night) added. This is then reviewed and approved in the Content Management System (CMS) and added back into the queue. Once in the queue the Business Area can check that the data is correct.

All 7 releases that required time series, were pulled out of the queue and the time-series files were added. They were all reviewed and approved, except Quarterly National Accounts which was reviewed but not approved.

The system is not automatic and we have a limited amount of time to do this work before 09.15 when all content should be in the queue.

The publication was not approved and because of this the system did not publish the release.

Once the content had passed its scheduled publishing time without approval, the system required manual intervention to publish the content. This manual intervention was delayed until checks revealed the release was not published on the live website.

The release was published at 09:34.

The Publishing Team now run an additional check on the preview site (part of the CMS) to ensure all time-series due to be published are present in the preview. This check will identify any similar instances where content due to be published has not been approved.
