1. Apologies

Apologies were received from Dr Bowe.

2. Declarations of Interest

Sir Jon Shortridge advised the meeting that, in respect of consideration of a draft complaints policy and procedure, he was a member of the Audit Committee of the Parliamentary and Health Service Ombudsman and would therefore have to withdraw from consideration of any complaints that might be escalated to the Authority Board under that procedure in the future.

3. Minutes and Matters arising from the Previous Meeting

The minutes of the previous meeting held on 17 December 2010 were accepted as a true and fair account. There were no matters arising.

4. Reports from Authority Committee Chairs

Assessment Committee

4.1 Professor Jowell reported on the meeting of the Assessment Committee held on 12 January 2011. Twelve draft Assessment Reports had been considered and the meeting had recommended that four of these should be further discussed by the Authority Board, and these would be considered later in the meeting.

Office for National Statistics Board (ONS)

- 4.2 Lord Rowe-Beddoe reported on the meeting of the ONS Board held on 14 January 2011. In addition to considering the monthly report from the Director General, the meeting had also considered a draft statistical work programme and outline business plan for the period 2011 to 2015, as well as a report on the ONS data collection strategy. It was agreed that the Authority Board would consider the ONS data collection strategy at a future point in the year.
- 4.3 The Board had also received a report on the work that had been conducted to minimise pre-release access to ONS statistical releases.

5. Census 2011

- 5.1 Ms Matheson reported on progress with the Census since the last meeting. The UK Census Committee had met in Belfast on 26 January to consider progress with the Census across the UK. The ONS Board would be meeting in Titchfield on 11 February and this would include visits to the 2011 Census and Beyond 2011 business areas. The Report of an independent review of the measures in place to ensure the confidentiality of census data would be published in February. The publicity and public information campaign would start on 21 February.
- 5.2 The meeting noted progress and agreed that the ONS Board should report back on their discussions about the Census and the visit to ONS in Titchfield at the next meeting.

6. Pre-Release Access to Official Statistics [SA(11)01]

- 6.1 Mr Bumpstead presented a paper which provided background information regarding the statutory arrangements for pre-release access and summarised the Authority's most recently stated position on change to that statutory position. The Authority had published 84 Assessment Reports and 13 of these contained Requirements and 18 contained Suggestions related to pre-release access.
- 6.2 The Authority noted that ONS had undertaken work to minimise pre-release access.

The meeting agreed that, in order that the Authority could monitor the situation across the official statistics system, a Report on pre-release access arrangements should be submitted to the Board annually.

7. Crime Statistics

- 7.1 Ms Matheson reported that she had accepted an invitation from the Home Secretary to lead an independent review of crime statistics with the aim of increasing public confidence in these statistics. The review, which it was expected would last three months, would:
 - i. review gaps, discrepancies and discontinuities in crime statistics but would not make detailed proposals about offence classifications;
 - ii. look at the future location for the publication of crime statistics outside of the Home Office; and
 - iii. produce an action plan for implementing the recommendations regarding public trust contained in the UK Statistics Authority's *Monitoring Report 5: Overcoming Barriers to Trust in Crime Statistics.*
- 7.2 The Authority welcomed these developments. It will be kept informed of progress.

8. Statistical Expenditure Reports [SA(11)02]

- 8.1 Mr Alldritt introduced a paper which reported on progress in developing Statistical Expenditure Reports (SERs) and presented outline drafts of two SERs. At the meeting on the 24 September 2010 the Authority had considered proposals on how it might monitor and respond to proposed or implemented changes in statistical work in order that it could take a view on specific cuts and report to Parliament as necessary.
- 8.2 The Monitoring and Assessment team were developing a process for producing SERs and the initial drafts were submitted for consideration by the Authority.
- 8.3 The meeting agreed that the drafts should be further developed and presented to a future meeting in due course. It was noted that the Department for Communities and Local Government (DCLG) had announced on 27 January that the Citizenship Survey would be cancelled at the end of March 2011.

9. Assessment Reports for Approval [SA(11)03]

- 9.1 The Head of Assessment, Mr Alldritt presented a summary of the following Assessment Reports which he and the Assessment Committee recommended be published:
 - i. Assessment Report 85: Statistics on National Insurance Numbers Allocated to Adult Overseas Nationals Entering the UK;
 - ii. Assessment Report 87: Statistics on Short-term Migration for England and Wales;
 - iii. Assessment Report 88: Statistics on Local Government Finance in Wales;
 - iv. Assessment Report 89: Statistics on Transport in Wales;
 - v. Assessment Report 92: Consumer Trends;
 - vi. Assessment Report 93: Statistics on UK Trade in Goods;
 - vii. Assessment Report 94: Effects of Taxes and Benefits on Household Income; and
 - viii. Assessment Report 95: Statistics from the Survey of Carers in Households.
- 10.2 It was agreed that all of these Assessment Reports should be published.

10. Draft Assessment Reports 86, 90, 91 and 96 [SA(11)04, 05, 06, 07]

10.1 Mr Laux introduced the following draft Assessment Reports which had been considered at the meeting of the Assessment Committee on 12 January and it had

been agreed that these should be considered further by the Authority Board:

- i. Assessment Report 86: Statistics from the General Lifestyle Survey;
- ii. Assessment Report 90: Statistics on Construction Price and Costs;
- iii. Assessment Report 91: Statistics on Patient Experience in England; and,
- iv. Assessment Report 96: Statistics on Scottish Community Care.
- 10.2 It was agreed that Assessment Report 91: Statistics on Patient Experience in England and Assessment 96: Statistics on Scottish Community Care should be published, subject to agreed amendments.
- 10.3 The meeting also agreed that the Head of Assessment should consider the implications of ONS proposals with regard to the General Lifestyle Survey before proceeding with Assessment Report 86: Statistics from the General Lifestyle Survey.
- 10.4 It was agreed that Assessment Report 90: Statistics on Construction Price and Costs should be published, subject to agreed amendments, and that these statistics should not be published badged as National Statistics until the Requirements had been implemented.

11. Any other business

- 11.1 The meeting considered a draft complaints policy and procedure, which had been circulated, and agreed that this should be published on the Authority's website, subject to agreed amendments.
- 11.2 The Chair reported that he had responded to letters from Andy Burnham MP and Andrew Bridgen MP concerning, respectively, statements made by Ministers and Opposition spokespersons regarding participation in schools sports activities. The Chair had also replied to letters from Sir Robin Wales, Mayor of Newham and Councillor Steve Reed, Leader of Lambeth Council regarding the presentation of information about local government funding by the Department for Communities and Local Government (DCLG). All of this correspondence had been published on the Authority's website.
- 11.3 Ms Matheson reported that the Government had announced plans for the creation of a Public Data Corporation Ms Matheson would keep the Authority Board updated on developments.
- 11.4 There was no other business.

Minimising pre-release access to official statistics

Purpose

- 1. This paper invites the Board to consider the extent of pre-release access to official statistics, provides background information regarding the statutory arrangements for pre-release access and summarises the Authority's most recently stated position on change to the statutory regime for pre-release access.
- 2. This paper also covers **Annex 1** which lists the requirements and suggestions arising from the Authority's Assessments of official statistics in respect of how departments' administer their pre-release access regime.

Recommendations

3. Members of the Authority are invited to discuss the issues arising from this paper, and to consider whether it would be useful to receive monitoring information on the extent of pre-release release access granted to official statistics produced by departments and, if so, in what form and with what frequency the Board would wish to receive such information.

Discussion

- 4. Since the *Statistics and Registration Service Act 2007* came into force in April 2008, particular attention has been paid to the new statutory arrangements for pre-release access to official statistics and what the legal framework should look like. Underpinning the Statistics Authority's position is the view that pre-release access should be minimised in terms of both the number of people to whom privileged early access is granted and the number of statistical releases and outputs where pre-release access is given.
- 5. The Authority's Monitoring Report reviewing the statutory arrangements for pre-release access observed:

'There is currently a widespread expectation that Ministers and Departments must be able to give instant comments when new statistics are published. It is our view that this expectation will need to be changed in order to respect a very important principle of statistical good practice – equality of access. All the parties to public debate should ideally have the same statistical information available to them at the same time and only the minimum number of people should see statistical results before they are released.'

6. During the course of the Authority's Assessments, the Monitoring and Assessment team has gathered some evidence about the operational aspects of the pre-release access regime in respect of the particular statistics being assessed. In light of that, a number of Assessment Reports have contained requirements to be met and suggestions for improvement. Annex 1 lists those requirements and suggestions.

7. The Office for National Statistics has undertaken work to minimise pre-release access to individuals for ONS statistical releases. An account of this work was considered by the ONS Board at its meeting on 14 January 2011.

Background

- Pre-release access is the practice of making official statistics, and the written commentary accompanying them, available in advance of their publication to specific individuals not involved in the production of those statistics. In most cases, this includes Government Ministers and their advisers, and other non-statistical senior officials in Departments.
- 9. The *Statistics and Registration Service Act 2007* provides for the Government to propose to Parliament a set of detailed rules under which pre-release access to 'statistics in their final form' may be granted. These rules are set out in secondary legislation. Under the Act, the Statistics Authority is precluded from addressing the issue of pre-release access to statistics in their final form in the *Code of Practice for Official Statistics*. The Act also provides for the Devolved Administrations to determine, again through secondary legislation, the rules for pre-release access to wholly-devolved official statistics produced within their jurisdictions.
- 10. The *Pre-Release Access to Official Statistics Order 2008* came into force on 1 December 2008, setting out the rules for pre-release access to UK official statistics. The Scotland pre-release Order also came into force on 1 December 2008, the Northern Ireland Order on 1 April 2009, and the Wales Order on 21 October 2009.
- 11. The UK and Northern Ireland Orders closely mirror each other. The Scotland and Wales Orders differ from the UK and Northern Ireland Orders in several important respects, including the maximum period of access (UK and Northern Ireland – 24 hours; Scotland and Wales – 24 hours for market sensitive statistics and five days for other official statistics; and omission in the Scotland and Wales Orders of a presumption is that the number of people to whom pre-release access is granted should be kept to a minimum.
- 12. The Statistics Authority published an independent review of the statutory arrangements for pre-release access in the form of a Monitoring Report published in March 2010. The Cabinet Office published the Government's own review of the UK pre-release arrangements in November 2010. The Scottish Government published its review of pre-release arrangements in Scotland in July 2010.
- 13. In its report published in March 2010, the Authority made four recommendations to Government and Parliament:
 - i. All the UK administrations should seek to amend their Orders to adopt a maximum period of pre-release access of three hours, with a shorter period as the norm;
 - ii. The four UK administrations should work together to share a common understanding of the arguments and develop a common formulation for the Orders, beyond the adoption of the three-hour limit;
 - iii. Remove provision for 'the making of statements about an official statistic at...the time of publication' and include an interval of one hour, on a voluntary basis, between the release of statistics and the release of ministerial comment; and
 - iv. Remove provision for the granting of pre-release access to journalists.

14. The UK Government's subsequent review proposed no changes to the current statutory framework for pre-release access to official statistics. Likewise, in its review the Scottish Government proposed no changes to the arrangements for pre-release access to wholly-devolved Scottish statistics.

Of the Requirements to review or reduce pre-release lists, three concerned statistics produced by Office for National Statistics (ONS) (Labour Market Statistics, Balance of Payments, and Overseas Travel and Tourism), one concerned statistics produced by the Health and Safety Executive (Health and Safety Statistics) and one concerned statistics produced by the Department for Health (Cancer Waiting Times).

- 3. In the 84 published Reports, the Authority has made 18 Suggestions related to pre-release access. Eight of these are Suggestions for the Scottish Government to publish lists of those with pre-release access to its statistics. This issue has been well documented. In essence, Scottish legislation does not require the Scottish Government to publish pre-release access lists (although it does require them to keep records of those who have been granted early access). The Authority's position is that the legislation does not preclude Scottish statisticians from publishing lists, and that publishing lists would improve transparency.
- 4. Two Suggestions relate to reviewing pre-release lists (both are directed at the Scottish Government). Seven Suggestions relate to improving the transparency of pre-release procedures, for example by providing clear links to pre-release lists or amending guidance.
- 5. A recent development has been the inclusion of a Suggestion for ONS to publish a summary of the changes made to the pre-release access lists for Consumer Prices Indices (Report 79). This Suggestion was made in light of evidence from ONS that it had completed a corporate review of pre-release access lists. The current pre-release list for Consumer Prices Indices includes over 40 recipients.

Statistical Expenditure Reports

Purpose

1. To update the Authority Board on progress on the first few Statistical Expenditure Reports (SERs), and to seek views on the drafts of the first two SERs.

Recommendations

2. Members of the Authority Board are asked to:

- note the steps taken by the Monitoring and Assessment team (paragraph 4); and
- comment on the drafts of SER1: Department for Communities and Local Government's (DCLG's) Citizenship Survey (Annex A) and SER2: DCLG's Place Survey (Annex B), in particular whether we might include two additional sections about:
 - o (our view of) the intrinsic value of the set of statistics in question in which we might for example note that the Citizenship Survey provides information relevant to the Big Society agenda, or in other cases whether a particular set of statistics has particular value because it supports a long time series); and
 - o the loss of expertise, knowledge and analytical capacity that a particular cut represents.

Discussion

- 3. At its meeting on 10 December 2010, the Committee for Official Statistics (COS) commissioned the Monitoring and Assessment team to produce draft SERs on the Citizenship Survey, the Place Survey, and Statistics on Schools in Scotland, based on information provided about the impact of cuts on official statistics [SA(COS)(10)26] and earlier discussion at the Authority Board [SA(10)54]. The aim of this work is to ensure that the Authority is in a position to advise Parliament on decisions that are made. Establishing our role in advising Parliament may also serve to enhance our influence over aspects of what is decided.
- 4. The Monitoring and Assessment team has now developed a process for producing SERs, and piloted it in the preparation of the first reports. The process seems to work satisfactorily; early indications are that we will be likely to streamline it, minimising the work involved and the burden on producers. The team has held meetings with the Head of Profession in the DCLG and the Chief Statistician in the Scottish Government, and plans to present the three SERs to COS on 4 February.
- 5. The draft SERs about DCLG's Citizenship Survey and Place Survey are at Annexes A and B. They adopt a structure that we are proposing to be the standard format for future SERs, and, at four to five pages, are the length that we envisage as being the norm. The Board's views on these issues, and the level of detail presented, would be welcome. For information, each SER took about a day to produce, and involved a one hour meeting with the Head of Profession.
